### Pre-Made Shipping Labels

Included in this document are six pre-made address labels for the 2010 ENnies season. Before shipping, please read the following:

1. Products submitted must be samples of those primarily available to the general public. If a product sells out, a PDF substitute is not acceptable.
2. Electronic and PDF entries may be provided on CDs which are clearly labeled with company name and titles. Please include a text file containing an index of all files on the CD. Software must be provided ready to install with full activation and codes.
3. In order to reduce waste, please consider submitting your Electronic and PDF entries via download. Contact the Submission Coordinator at [entries@ennie-awards.com](mailto:entries@ennie-awards.com) for more information on how to do so.
4. The ENnies require six copies of each title: one for each judge, and one (a.k.a. the "6th Copy") which is used as reference material during the judging period, for display purposes at Gen Con Indy, and possibly for fund raising purposes.
5. There is no entry fee for submitting physical product. There is a \$5 convenience charge for submitting via download.
6. Contacting judges to discuss your submissions is strictly forbidden. If you have questions or concerns, contact the Submission Coordinator at [entries@ennie-awards.com](mailto:entries@ennie-awards.com)
7. Judge's phone numbers for shipping purposes only are available upon request.
8. Please be certain to include the entire shipping label and/or to include text on customs forms declaring that the shipment is for promotional/evaluation purposes only, not for resale, declared (for customs) value \$0.
